#### **Financial Update**

We have about \$31,000 coming in and about \$36,000 going out. Alliance will go down to \$4,000 a year. Will spend about \$5000 more than we bring in. Hope to go to 4 mils as a CID or go to a BID and have expanded membership. Carrying \$33,000 over.

Need to include funding for Georgia Works in budget. Look for ways to share resources with Alliance - audit, etc. Budgeted \$200 for PPT to potential members.

Anna motion to accept 2021 budget. Second from Walter. Unanimous approval.

# 2021 Priorities Review

\$3M leverage - outlined in the fundraising doc; doesn't include GDOT investment. At least \$2.4M. Without the CID it would have languished, priorities could have shifted. Lauren to find out.

Add a bullet in priorities around partnering with social services to support people experiencing homelessness.

It's the only place they bump over Moreland Ave. If we have any case to Edgewood Retail, it's to fight that special tax.

Goal is to have the conversion legislation at the city level done so that we can tell the tax commissioner on June 30 that we have this set of properties under this new BID. Would concurrently terminate the CID and form the BID. Would need new consent forms from current CID members.

#### 3. Alliance

Most of the work has been with the strategic planning committee. Coming up on the end of the work. New public safety chair will help move us forward. Report will be finished in February. BA will take on more of the events and programming while Alliance will be more around the strategy.

#### 4. GDOT/Moreland Ave. update
